Letter # 3: Dear Main Office,

I did not receive reply to my inquiry.

I need to communicate with SA medical team or anyone in the organization responsible for demanding mandatory weekly testing of unvaccinated scholars.

I would like to see the scientific documentation supporting the weekly mandate. In my professional understanding, the rate of transmission of vaccinated and unvaccinated people is the same.
